MEDICAL LABORATORY TECHNOLOGY PROGRAM APPLICATION CHECKLIST

The Med Lab Tech program gives students an AAS degree by completing five semesters of curriculum. The curriculum includes clinical lab techniques, liberal arts and science courses, and a six month hospital assignment.



You must meet these minimum requirements (#1-9) to be eligible to be admitted to the MLT program. Admission is based on seat availability.

If you have completed college coursework elsewhere, you must have **official transcripts** sent for transfer evaluation. Send to:

4. ALEKS Math Assessment Minimum score 30 or ACT Math score 20				
5. ACCUPLACER Reading				
Minimum score 248 or ACT Reading score 19				
6. ACCUPLACER Writing				
Minimum score 254 or ACT English score 19				
7. Submit evidence of "C" or better in one year of high school Biology or equivalent				
Equivalents include college level BIO 104, BIO 112, or Academic Achievement Center Biology I and II				
8. Submit evidence of "C" or better in one year of high school Algebra or equivalent				
Equivalents include college level MAT 099 or MAT 064				
9. Submit evidence of "C" or better in one year of high school Chemistry or equivalent				
Equivalents include college level CHM 122 or Academic Achievement Center Chemistry I and II				

*BIO 164 Essentials of Anatomy & Physiology is a required course in the MLT program. Students are strongly encouraged to take this course or an equivalent prior to starting the MLT program.
